STATEMENT MODIFICATION ORDER 2021

This Order is made by the Kent County Council ("the authority") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the part of Public Footpath AE639 and Public Footpaths AE338 and AE337A described in paragraph 1 below are not needed for public use, and thereupon the Definitive Map and Statement (Map Sheet 127 [TR04SW]) for the County of Kent shall be modified accordingly.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the definitive map and statement (Map Sheet 127 [TR04SW]) for the County of Kent requires modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted or widened or extended.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order.

Ashford Borough Council has been consulted as required by section 26(3) of the 1980 Act.

By this Order:

1. The public rights of way over the land situate at the Inland Border Post and Lorry Park at Sevington and shown by a bold continuous line on the attached map contained in the Order and described in Part I of the schedule to this Order shall be extinguished from the date of confirmation of this Order and thereupon the Definitive Map for the County of Kent (Map Sheet 127 (TR04SW)) shall be modified by deleting from it those public rights of way.
2. The relevant date of this Order will be as specified in paragraph 1.
3. The Definitive Statement for the County of Kent (Map Sheet 127 [TR04SW]) shall be modified as described in Part II of the schedule to this Order.



SCHEDULE

PART I: DESCRIPTION OF PATHS TO BE EXTINGUISHED

The entire width of (A) that length of Public Footpath numbered AE639 commencing from its junction with Public Footpath AE337A and running in a generally south-easterly direction for approximately 512 metres to its junction with Highfield Lane, as shown between the points F and B on the Order Plan.

The entire width of (B) that length of Public Footpath numbered AE338 commencing from its junction with Public Footpath AE337A and running in a generally north-easterly direction for approximately 190 metres, as shown between the points H and J on the Order Plan.

The entire width of (C) that length of Public Footpath AE337A commencing from its junction with Public Footpath AE639 (approximately 80 metres to the south-east of St. Marys Church at Sevington) and running in a generally north-north-easterly direction for approximately 320 metres, as shown between the points F, H, and I on the Order Plan.

PART II: MODIFICATION OF DEFINITIVE STATEMENT

The entry for Public Footpath numbered AE639 is modified by the addition of the following:

Part extinguished, at the Sevington Inland Border Post and Lorry Park by the Kent County Council (Public Footpaths AE639 (part), AE338 and AE337A Sevington) Public Path Extinguishment and Definitive Map and Statement Modification Order 2021.

The entry for Public Footpath numbered AE338 is modified by the following:


